That the principal and Correspondent /Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the board from time to time. The School undertakes to abide by the provisions contained in the affiliation & examination byelaws, direction issued from time to time and the law of the land.
